Are JUULs and other Vape Cigarettes Deadly?

Initially thought up as a way to quit smoking cigarettes, Juuls and e-cigarettes have become better known for the issues that they are now causing users. Not only are they grabbing the attention of teenagers and younger users, but they are also dumping higher amounts of nicotine into older smokers as well.



As of recently, there have been more than 18 deaths and 1,000s of cases of serious lung injuries and illnesses related to vaping and e-cigarettes. Unless you have been living under a rock, you know that even the Federal government has begun to step in to try and curb the use of these products.

How do e-cigarettes such as Juul's work? By creating an internally "heated" vapor or aerosol that is easily inhaled by the user. The manufacturers add flavoring to the vapor to ensure that the user has a pleasant experience and doesn't taste the tobacco products, chemicals, or other additives to the mixture. These flavors, such as vanilla, bubble gum, mint and others, make it seem that they are harmless, but the fact is, that the liquid e-cigarettes can contain double the concentration of nicotine. Juuls specifically have become the target of some significant lawsuits filed across the country. There is one specifically blaming the device for a child's death and one that is targeting the addiction users gain when using the product. Juuls and other vaping devices have become the cigarettes of this generation, and young users are becoming addicted and getting harmed because of it.

So what is with all the articles on lung issues and even some deaths? Well, Juuls and other e-cigarettes have been shown to lead to lung issues among users. Whether they are healthy or not, there have been numerous cases where vaping has been potentially tied to lung infections, pneumonia, seizures, and even chemical burns from exploding units.

Currently, there are investigations underway nationwide on the impact of Juuls and other devices and the premise that they were created as a way to quit smoking. It has even been mentioned that manufacturers such as Juul specifically targeted younger users in their marketing to get them addicted to the high doses of nicotine, all issues facing the cigarette manufacturers in the late 90s.

In December of 2018, the United States Surgeon General declared vaping an epidemic and lumped the product in with cigarettes. The Surgeon General

Your Home: 5 Fall Tips for a Healthy Yard

(eLivingtoday.com) Giving your lawn a little autumn attention as it works to absorb energy, moisture and nutrients to sustain it through the colder months can pay dividends with a lush, healthy yard next spring. Consider these tips to take advantage of the fall growing period:



Mow: Grass continues to grow until the first frost, so it's important to keep mowing throughout the fall. Ideally, you should keep your yard at 2 1/2-3 inches in height, which is short enough to prevent matting and fungi like snow mold yet long enough to keep the root system deep enough to withstand the cold and dryness of winter.

Aerate: Because your yard typically suffers some degree of soil compaction and heat stress, which can lead to brown or thinned grass, regular aeration can prevent soil from compacting and defend against thatch – a layer of roots, stems and debris – that blocks water, oxygen and fertilizer from reaching the roots.

a suffocating mat on your grass, potentially leading to fungal diseases.

Fertilize: Because grass grows slower as the weather cools, fall is the ideal time to fertilize. In mid-to-late-fall, apply a dry fertilizer to your grassy areas to provide necessary nutrients and encourage deep roots and denser growth that can better compete with weeds and tolerate disease and insects.

Over-seed: A dense lawn not only looks good, but also helps protect against weeds. Over-seeding your existing turf can help fill in any thin or bare spots and also introduces the resilient grass seed.

Rake: When leaves fall on your lawn, they can block out sunlight and, if left too long, stick together to form

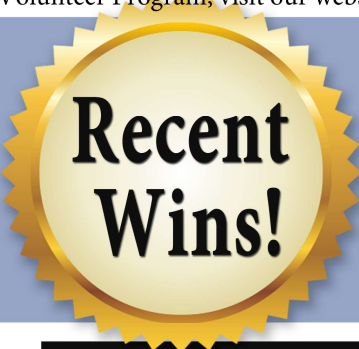

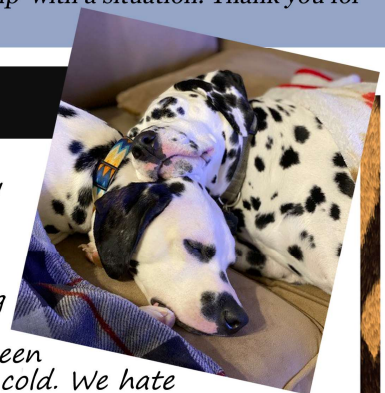

Recipe of the Month: **Slow Cooker Green Bean Casserole**

Ingredients:

2 (16 oz.) packages frozen cut green beans
2 (10.5 oz.) cans cream of chicken soup
2/3 cup milk
1/2 cup grated Parmesan cheese
1/4 tsp salt
1/4 tsp ground black pepper
1 (6 oz.) can French-fried onions, divided

Directions:

1. Combine green beans, cream of chicken soup, milk, Parmesan cheese, salt, black pepper and half of the French-fried onions in a slow cooker.
2. Cover and cook on Low for 5 to 6 hours. Top casserole with remaining French-fried onions to serve.

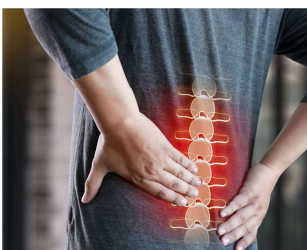

Car Pulls Out in Front of Motorcycle, Rider Injured!

Our client was riding his motorcycle on Route 857, close to the I-68 off ramp, when a car traveling on South Pierpont Road did not properly follow the rules of the road and pulled out in front of his motorcycle.



Upon impact, he was thrown from his bike and he suffered, among other things, a broken leg and a broken wrist.

After receiving treatment at the scene of the accident, our client was then taken to an emergency room where he underwent immediate surgery that placed screws in his leg. He is also currently recuperating from the surgery that was required to put

his broken wrist back together. He will have months of continued care before he may be able to get back on his motorcycle.

Car vs. Tractor Trailer on the WV Turnpike

We were hired by an out of state traveler that was passing through from North Carolina headed to St. Louis. Unfortunately for her, her trip was detoured when she was ran into by a tractor trailer that miscalculated his merge into her lane.
