Who is at Fault in a Multi-vehicle Accident?

It is common to hear about multi-car pileups in the news, the most recent in our region being a 58-vehicle pileup on Interstate 68. The increased number of vehicles on the road smart phones and other things that distract drivers, vehicle pileups are more likely to occur. Throw highway speeds and a bit of bad weather or dense fog, and it is almost guaranteed a pileup will happen on any stretch of highway.

But who is responsible for the accident after it happens? Whose insurance company is going to foot the bill? This is where it gets complicated.

Once the seriously injured are taken from the scene and as the wreckage is removed by tow trucks, the responding law enforcement agency begins to take notes, interview witnesses and hopefully snap some pictures or grab some video. Reconstruction of the accident starts with the investigation and generally ends with a police report. (The picture to the right is a sampling of what is contained in such a report.)

In West Virginia, determining who started the chain reaction will be based on the information gathered on the police report. Some multi-car pileups end with a few drivers that share some of the responsibility and some of the blame. But how does that translate to insurance claims, and who is going to pay for the damage? Law enforcement compiles all of the information into one comprehensive report that is then reviewed by the interested parties. It is not uncommon for the responding officer to not officially declare one driver to be at fault, especially if the weather was a factor in the accident.

Insurance companies love multi-car pileups, primarily when the party responsible can not be



determined. We see time and again, insurance companies immediately denying liability either claiming someone else was at fault or that, at a minimum, their driver did not cause the accident and therefore shares no responsibility. At this point, an attorney must review the claim to help determine who should be held accountable, and it generally turns out to be one of those insurance companies that immediately denies any liability.

Hiring an attorney if you are involved in a multi-vehicle pileup is essential. Everyone knows that it is hard enough to get fairly compensated for injuries when we know precisely who was at fault, let alone in a situation where it is up in the air, or the blame lies with multiple people.





• Flowers & Plants: Poinsettias, holly, mistletoe, lilies and amaryllis are known for their toxicity to cats. Nibbling plants and flowers could result in a road-trip to the emergency vet! Choose non-toxic plants or use silk flowers instead.

Recipe of the Month: Pork Roast, Sauerkraut and Kielbasa

Ingredients:

1 (2 pound) boneless pork loin roast 2 Tbsp olive oil 2 sprigs fresh thyme leaves

salt and pepper to taste 4 pounds sauerkraut

1 pound keilbasa, cut into 3 inch pieces



Directions:

- 1. Preheat the oven broiler. Place the roast in a roasting pan, brush with olive oil, sprinkle with thyme leaves, and season with salt and pepper. Place under the broiler for 10 minutes, until lightly browned in several places.
- 2. Place 2 pounds sauerkraut in a slow cooker. Arrange keilbasa pieces around the edges of the slow cooker pot and place the roast in the center. Cover with remaining sauerkraut.
- 3. Cover slow cooker and cook roast 6 hours on high.
- 4. Remove roast from pan and cut into slices and plate with both the sauerkraut and the keilbasa for an awesome New Year's Dinner celebration.

Multi-Car Accident on I-79 Leads to Injuries!

Our client was driving south on interstate 79 near the Meadowbrook Mall exit when he was struck from behind by a large truck that was attempting to merge into his lane. This small collision caused a chain

reaction that caught two more cars in its wake. Of the four drivers, our cleint received the most injuries as his vehicle was struck a number of times.

After receiving treatment at the scene of the accident, our client was then taken to UHC's ER where he underwent multiple x-rays. He was diagnosed with a broken leg, fractured clavical and bruised ribs. The

driver of the truck who caused the accident, denied any liability and currently his insurance company is siding with him. We will continue to investigate the accident while our client recovers to ensure that he is treated fairly and the driver of the truck takes responsibilty for his actions.

Assisted Living Passenger Injured Heading to Doctor

We were hired by the family of an assisted living patient that was injured while being taken to a medical appointment by the person charged with her care.

Upon entering the parking lot of the doctor's office, the caretaker ran right into an oncoming vehicle causing damage to the front passenger side of the car.
