Bicycle Safety Warning, Recent Deaths Lead to Call for Awareness

After two recent bicycle accidents resulted in deaths, local bicycle enthusiasts are calling for more awareness of bike riders in the area.

There is nothing bicycle riders enjoy more than getting out during nice weather to enjoy cruising along the Van Voorhis Trailhead in Morgantown or the Allegheny Highland Trails leading to Elkins. But there is another side to biking in our area that is known too well by many riders: the impatient drivers that believe the road is only for cars and the distracted drivers that are so engrossed in themselves that they are not watching out for others, including bike riders that are attempting to share the road.



roadways can also become an issue due to winding turns, rolling blind spots and even potholes.

West Virginia law requires that vehicle drivers share roadways with bike riders, in fact in a few cities and towns dotted throughout the area, you will see signs and even bike lanes that proclaim as much. However, time and again we see the blatant disregard for the rules, many of those instances leading to injured bike riders.

UPDATE: Zantac Lawsuit Moving Forward

Almost 17,000 people have joined the multidistrict litigation case over allegations that talcum-powder products have caused cancer. Should you join the lawsuit?

Recipe of the Month: Grilled Corn Salad

Ingredients:

- 6 ears freshly shucked corn
- 1 green pepper, diced
- 2 Roma tomatoes, diced
- 1/4 cup diced red onion
- 1/2 bunch fresh cilantro, chopped
- 2 tsps olive oil
- 1 pinch salt and ground black pepper to taste



Directions:

1. Preheat an outdoor grill for medium heat; lightly oil the grate.
2. Cook the corn on the grill, turning occasionally, until the corn is tender and specks of black appear, about 10 minutes; set aside until just cool enough to handle. Slice the kernels off of the cob and place into a bowl.
3. Combine the warm corn kernels with the green pepper, diced tomato, onion, cilantro and olive oil. Season with salt and pepper; toss until evenly mixed. Set aside for at least 30 minutes to allow flavors to blend before serving.

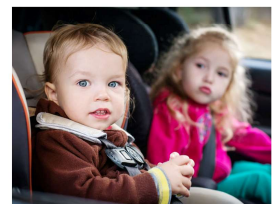


Unfortunately, for our client, she received multiple bites, including on her chest and torso. A report was filed and the case was referred to us from a local agency. We are currently investigating available insurance policies to cover the damages.

Insurance Company Treats Local Family Poorly

Our clients were involved in an accident that injured both parents and three children. The insurance company involved accepted liability for the accident and settled the claims for the adults in the accident, but for some reason decided that the injuries sustained by the children were not their responsibility. So the family reached out to us for assistance.

Each of the three children sustained injuries in the accident. Two children had injuries to their face, including a damaged eye socket and the other may have had smaller injuries, but they were injured just the same. Their claims deserve to be treated just as they would be as an adult and we intend to hold the insurance company accountable.

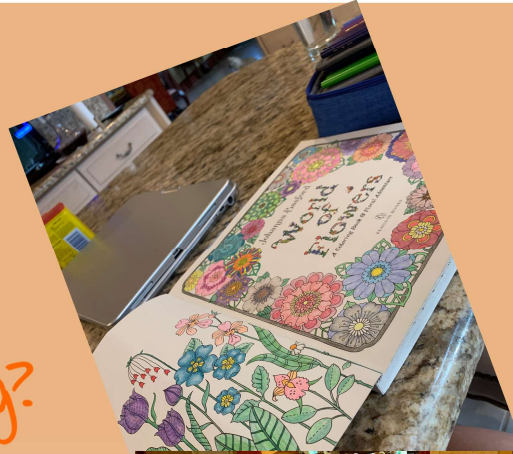
