### Is it Better to Settle Your Claim Out of Cour



Is it better to settle out of court? The short answer is that it depends on the nature of your case. However, settling your claim with the help of an attorney instead of taking it to trial is faster, less stressful and cuts out the uncertainty that comes with leaving the decision to a jury.

As personal injury lawyers, we have handled thousands of cases and, while each client is different and every case has its own unique set of facts, there are some questions that appear in virtually every case.

As a general rule, it is unlikely you will have to go to court to recover for your personal injury claim.

It's commonly cited that 95-96% of all civil cases settle out of the courtroom, but the real number may actually be slightly lower than that. Because settlements are private it's very hard to get an accurate account of the number of cases that avoid their day in court, though many cases are settled after years of preparation for trial.

Why do so many court cases settle out of court?

Settlements save both parties the effort, expense, and uncertainty of going to trial. They make sense as an efficient resolution to a lawsuit, if the parties can find a financial middle ground.

Judging the quality of a settlement offer is not an easy task. However, a good and fair settlement agreement is one in which you believe pays you a fair value for the injuries you suffered and the impact it has had on your life and that of your family.

While that doesn't necessarily mean that you were paid the highest possible value for your injuries, it does mean that you received an amount that fairly recognizes the harm you experienced, while also considering the risk that if you went to court a jury may have determined that your injuries were of less value.

Skilled lawyers will often tell you that a "good" settlement is one in which neither party feels fully satisfied; that is, both parties feel like they compromised their desired outcome to get a deal done.

#### Who decides whether to settle or go to trial?

It's always your choice, as the client, whether to settle your personal injury claim.

## Choosing the Right Hospital is a Life or Death Decision

(Family Features) When Judie Burrows, an adventurous, retired teacher, broke her hip during a bicycle accident, her family trusted the doctors and the hospital. They were not worried about a routine hip surgery.

"I didn't realize at the time that we should have worried, even though this was a routine procedure," said her son, Steve Burrows. "We thought all hospitals were basically the same."

Burrows, who produced the award-winning HBO documentary "Bleed Out" recounting his mother's story, points to an option like the Leapfrog Hospital Safety Grade as how his family might have compared hospital safety.



Five months later, with her first hip surgery failing, Judie Burrows fell and broke her hip again and spent eight days in the hospital in excruciating pain with no plan of care. She had a second hip surgery, despite the doctor knowing she was still on three different prescription blood thinners, and lost half the blood in her body.

After surgery, Judie Burrows slipped into a coma. For a day and a half, no one noticed.

"When my mother emerged from her coma after two weeks, her cognitive abilities were equal to that of an 8-year-old," Steve Burrows said. "She survived, but lost her fierce independence, her home and all her life savings, which were used to pay for the injuries she suffered."

"Health care is too important not to shop for it," said Leah Binder, president and CEO of The Leapfrog Group. Binder suggests a safety-first research strategy that begins with the Hospital Safety Grade, the only resource entirely devoted to errors, injuries and infections, followed by research from other sources into the quality of the surgery or treatment a patient needs.

## Pet Peeves: The Struggle of a "Simple" Stroll

Walk me human! It is inevitable your pooch will be itching to take a stroll throughout your local neighborhood. Sounds delightful, right? Think again! As your loving companion detects new smells, hears an interesting noise, or encounters your elderly neighbor on her porch — chaos will ensue!

An untrained dog needs proper and consistent training to master the art of walking. So, save yourself from embarrassment by checking out these brilliant techniques:

- #1 Introduce the leash and harness: Ensure the harness is snug fitting where is not too loose where the dog could slip out, but not too tight where it is uncomfortable.
- #2 Practice and perfect the "heel" command: Make sure you are consistent as to which side you pick for your pet to walk on. Have your pet's favorite treat in your hand, lower it to their nose, and take one step forward saying "heel". When your pet follows you, praise them with a treat for their obedience.
- #3 Manage pesky leash pulling by recalling them back then rewarding them with a treat and praise for their return.
- #4 Just remember... patience, patience, patience! Training takes repetition and time.



# Recipe of the Month: Zucchini Cornbread Casserole

### Ingredients:

4 cups shredded zucchini 1 onion, chopped 2 eggs, beaten 1 (8.5 oz.) package dry corn muffin mix 1/2 tsp salt 1/4 tsp ground black pepper 8 oz. Cheddar cheese, shredded



### Directions:

- 1. Preheat oven to 350 degrees F. Grease a 2 quart casserole dish.
- 2. In a large bowl mix together the zucchini, onion, eggs, muffin mix, salt and pepper. Stir in 4 ounces of the cheese.
- 3. Spread the mixture into a greased 2 quart cassserole dish; top with remaining 4 ounces of cheese.
- 4. Bake in preheated oven for 60 minutes.
