# Saying This to Your Insurance Company Could TankYour Claim?



You have just been in an accident, and you have insurance adjusters calling you constantly, almost to the point of harassment. BE CAREFUL! They are only trying to trip you up and get you to state something or sign something that could hurt your case.

You need to remember that insurance companies are a business, and like other businesses, they want to make a profit.

By paying you out less, the more money they will make. That is why insurance adjusters will try anything they can to get you to admit fault for your car crash so that they can justify paying you less than you deserve or deny your claim altogether.

For these reasons, it is important that when reporting an accident to your car insurance company or speaking with the insurance company of the driver who caused the accident (Which is a big no no already!), you do the following:

- 1. Do not admit fault.
- 2. Do not say you aren't injured. If they ask, you should be adamant that you are not sure.
- 3. Do not sign any release to give up your medical records without checking with your lawyer.
- 4. Do not accept any sort of settlement without consulting with an attorney first.
- 5. Do not make any staement to the insurance company without speaking to your attorney first.

The insurance adjusters have a set of rules they follow to process your insurance claim, with only one job in mind-to settle your case for as little as possible.

To accomplish this goal, they will start investigating the accident and looking for ways to blame you for it in hopes of ruining your chances of securing the compensation you are entitled to. Do not make statements that can destroy your credibility or establish you were somehow at fault for the crash.

If you have been involved in a motor vehicle accident, the answer is simple-you need to hire an experienced accident lawyer.

Do not wait to get legal help if a car accident disrupted your life or the life of a family member.

## Paraquat in Herbicides Causes Parkinson's in Farmers

Paraquat. If you have never heard of it, you might not have used it. But if you use herbicides in your daily life or for your employer, you probably are very familiar with it. Paraquat does what it needs to do, it kills weeds and other destructive plants. It did its job quickly and could be applied easily through direct and indirect spraying. However, it also created havoc on the health of the user.

Parkinson's Disease. Parkinson's disease is a disorder in the central nervous system that affects the movement of the body. It can cause hardship for those afflicted with day-to-day normal movement and it can cause uncontrollable tremors. Parkinson's is a degenerative disease that attacks the brain and creates a deficiency in it's ability to communicate with the rest of your body through the nervous system.

How is Paraquat connected to Parkinson's Disease. Paraquat can cause Parkinson's, in fact a 2011 study by the National Institutes of Health found that those exposed to Paraquat are 2.5 times more likely to develop Parkinson's

Yes in 2011 this study was done and the results published. Ove the years this has lead other countries to ban the use of the herbicide. The United States Environmental Protection has not only NOT banned its use, it refused to ban it late last year when provided the opportunity.

Do you use Paraquat at your job or on a farm? Businesses and consumers are using over 10 million pounds of the herbicide each year and as weeds become resistant to the likes of Round Up, the use has and will only increase.

What does that mean for you? Well, if you have had an extensive history of using Paraquat and have been diagnosed with Parkinson's Disease, you may have a claim. ## Recipe of the Month: Tres Leches

### Ingredients:

- 1 1/2 cups all-purpose
- 1 tsp baking powder 1/2 cup unsalted butter
- 1 cup white sugar
- 1/2 tsp vanilla extract
- 1 (14 oz.) can sweetened condensed milk
- 11/2 cups heavy 1 (12 oz.) can evaporated
- 1 cup white sugar
- 1 tsp vanilla extract
- 5 eggs
- 2 cups whole milk

## (Milk Cake)



### Directions:

- 1. Preheat oven to 350 degrees F. Grease and flour one 9x13 in baking pan. Sift flour and baking powder torgether and set aside.
- 2. Cream butter and the 1 cup sugar until fluffy. Add eggs and the 1/2 tsp vanilla extract; beat well.
- 3. Add the flour mixture to the butter mixture 2 Tbsps at a time; mix until well blended. Pour batter into prepared pan. Bake at 350 degrees F for 30 minutes. Pierce cake several times with a fork.
- 4. Combine the whole milk, condensed milk, and evaporated milk together. Pour over the top of the cooled cake.

### Medical Condition Leads to Accident w/Injuries

Our client was a passenger in her boyfriend's car, when he had a medical episode which cause the vehicle to veer into a tree with the impact directly on the passenger side of the vehicle

Initially, it was listed on the police report, that our client was the driver, however, that was clarified after her boyfriend

spoke to his insurance company.

Unfortunately, for our client, the other driver has denied liability and has pushed their side of the story with the insurance companies. 
