Hiring a Lawyer **Does Not** Mean You Will End Up in Trial

There is a common misconception out there that most people believe when considering to hire an attorney. Most people believe that if you hire an attorney to take on your accident case, whether it is a car crash or a dog bite injury, that you will end up at trial in court, before a judge. We are here to tell you that most clients we have served have not had to take one step into a courtroom. Nationally, it is believed that only 5-6% of all accident cases end up in court. So that means that 95% of all accident claims **do not** end up in court. We see that statistically with our clients as well.

Why you ask, will your claim not go to trial?

1. Our attorneys know the approximate value of your claim. After years of experience, our attorneys have an idea of how much each claim is worth after all of the evidence is gathered. With that in mind, we are in an excellent position when dealing with an adjuster and generally can get a claim settled even before a lawsuit is filed. (Keep in mind, the goal is to get the best amount available for your claim, and we are prepared to go to trial.)

2. The insurance company does not want to pay the expense of a trial. Trials are expensive. Insurance companies have to hire attorneys, experts, etc. when they go to trial. The primary goal for an insurance adjuster is to keep the costs low for his or her company, whether that is to avoid a trial and settle, or attempt to undercut the value of the claim. In either instance, having an experienced attorney that knows the process and the value of your claim



will always put you in the best position. (Did you know that when you hire an attorney, on average what you pocket from your claim is 30-40% higher?)

3. Going to trial is generally caused by the insurance company not agreeing with your attorney. The number one reason that accident cases go to trial is because the insurance company has either not accepted responsibility for the accident or is unwilling to settle the case for what your attorney thinks is appropriate. When we submit a demand to the insurance company, we have already gathered the evidence needed to support your claim. If your case gets to this point, and again only a small portion do, your attorney is prepared.

Our attorneys understand the process and have extensive knowledge and experience when dealing with accident injury claims. We understand the motives of the insurance adjuster and know the tactics they use to reduce your claim. We know that most people want to avoid going to court. Although we cannot guarantee your case will not go to trial, we can ensure that we will get you the best outcome possible for your claim and the circumstances you find yourself in.

Spotlight: How Dangerous is RoundUp? Should You Be Worried?

The answer is YES, you should be worried about the dangers of RoundUp. What specifically are the dangers? Well how about non-Hodgkin's lymphoma? Those words alone should cause you some concern.

Glyphosate, the primary chemical in RoundUp has been recently linked to non-Hodgkin's lymphoma by experts in a federal court case. That connection led to a jury returning a \$289 million verdict for damages. This and other recently filed lawsuits claim that Monsanto, the embattled maker of RoundUp, knew about



the cancer risk, and chose to ignore it as they marketed their product to unsuspecting homeowners.

What does this verdict mean for those West Virginians that have used this chemical in their gardens and on their lawns for years?

Well, it means that if you or a loved one has been diagnosed with non-Hodgkin's lymphoma or any other cancer and were consistently in contact with RoundUp, you may want to reach out to our office to learn more about this national case and how it could impact any claim that you may have.

Recipe of the Month: **Slow Cooker Taco Soup**

Ingredients:

2 pound ground beef
1 onion, chopped
1 (16 oz.) can chili beans w/liquid
1 (15 oz.) can of kidney beans w/liquid
1 (15 oz.) can whole kernel corn w/liquid
1 (8 oz.) can tomato sauce
2 cups water
2 (14.5 oz.) cans diced tomatoes
1 (4 oz.) can diced green chile peppers
1 (1.25 oz.) package of taco seasoning

Directions:

1. In a medium skillet, cook the ground beef until browned over medium heat. Drain and set aside.
2. Place the ground beef, onion, chili beans, kidney beans, corn, tomato sauce, water, diced tomatoes, green chile peppers and taco seasoning mix in a slow cooker. Mix to blend, and cook on Low setting for 8 hours.
3. Serve in a bowl with shredded cheese, sour cream and some tortilla strips as garnish.
